Please be advised that the Office of Inspector General has contracted with the independent certified public accounting firm, KPMG LLP, to conduct a risk assessment of the U.S. Department of Labor's charge card programs per the Government Charge Card Abuse Prevention Act of 2012. The act requires the OIG to perform periodic risk assessments of agency's purchase cards, combined integrated card programs, and travel card programs to analyze the risks of illegal, improper, or erroneous purchases.
